OFFICIAL RULES FOR INDIVIDUALS (RULES APPLY TO BOTH MEN & WOMEN):

1. Challenge Ground Rules:

- a. Contest opens to healthy individuals who are 18 years or older. He or she must show ID with proof of age, and sign the Waiver and Assumption of Risk.
- b. The objective is to set a new record for the Chef One Dumpling Eating Contest within 2 minutes. [No eating may begin prior to the start signal.](#)
- c. Each contestant will begin the competition with 40 dumplings and additional dumplings will be provided if the first 40 is finished.
- d. Contestants must stop eating at the 2 minute signal and will be allowed to swallow down any dumpling already in his or her mouth. He or she must open his or her mouth to prove the completion of eating. If anything slips out from his or her mouth during the final swallowing, he or she will be disqualified immediately.
- e. Dumplings cannot be smashed prior to or during the eating contest; doing so will result in disqualification.
- f. If a contestant vomits, he or she will be disqualified immediately.
- g. Any unfinished dumpling does not count toward the total number.
- h. The top three scores are the winners of this contest.
- i. **In the event of a tie, another 1-minute eat-off (All rules will be applied) will take place until a winner is selected.
- j. If you disagree with your score, or would like a re-count, please advise your scorer right away. All scores are final upon moving to the next round.

2. Prizes:

- Champion: Grand Trophy & \$2,000 check
2nd Place Winner: Certificate & \$1,000 check
3rd Place Winner: Certificate & \$500 check
